

America's Irreconcilable Ideological Divide

The apparent election of America's first mail-order president with its numerous cases of voter irregularities or fraud has demonstrated that modern-day America is more divided than at any time since 1860. This divide is far more than a mere partisan divide. It is more than just an old-fashioned heated but good-natured debate between liberals and conservatives. It is a divide that foreshadows future violence if a solution acceptable to both sides is not found. Unfortunately, America's ruling elites, flush with apparent victory and secure in their control of America's political and social institutions of influence and power, show no evidence of seeking a solution that would be acceptable to conservative, American-values voters in Red States and Red Counties. The 2020 presidential election is glaring evidence that there exists an irreconcilable, ideological divide between America's Blue State/County and America's Red State/County voters. The division is "irreconcilable" and therefore business-as-usual conservative efforts will not resolve the division—it is time to consider secession.¹

In many ways, America's current irreconcilable, ideological divide is similar to the divide of 1860. That divide was one of political ideas that were expressed in simplistic verbiage that was easily understood by the Northern popular mind. "Evil, racist, lazy, white Southerners were holding blacks in cruel bondage," was the popular image of the South promoted by radical Northern abolitionists. Republican politicians seized this popular Northern view and used it to give the impression of moral authority for its unconstitutional invasion, conquest, and occupation of the Confederate States of

America. It also gave “moral” cover for the subsequent exploitation and impoverishment of their newly acquired Southern economic colony.²

When the people of the South voted to remove themselves from the Union controlled by the North, the Northern political elite (the Republican Party) initiated an illegitimate war of aggression against a democratically elected, sovereign nation, the Confederate States of America. The people of the South expressed their desire to live under a government based upon their free and unfettered consent, a government that would not use its political power to extract tariffs (taxes) from one group for the benefit of another group, a government that would allow the people in each sovereign state to work out the social and political changes necessary to cure social issues, such as chattel slavery, in a manner that would be best of all concerned.

The North—under the influence of the Republican Party—was determined to keep the South in their (as in the North’s) Union because the South was providing over seventy percent of the revenues necessary for running the federal government. When Lincoln was asked “Why not let the South go?” he replied, “Where then shall we get our revenues?” This sentiment was expressed in numerous Northern newspapers.³ The South had become the Yankee Empire’s cash-cow—in modern parlance the South had become the Yankee Empire’s ATM (Automatic Teller Machine). The South became a source of unending revenue for greedy Northern politicians and commercial interests desiring to increase their political power and commercial profits via protective tariffs. Southerners wanted a constitutionally limited republic of sovereign states but the

political elites in the North wanted something very different. The Republican Party and its crony capitalist supporters wanted a centralized, all-powerful, central government controlled by the Northern majority and operating for the benefit of Northern political and commercial interests. There is no compromise between two such diverse ideologies. If they remain together under one government, the side with the majority of votes will rule while the other side will be “democratically” forced to submit. This is a basic principle of all empires—the stronger compels the weaker to submit. The Yankee Empire is no different.

The irreconcilable, ideological divide is just as evident in modern America. For example, neo-Marxists in Blue States want to use federal revenues to pay for partial-birth abortions, whereas, Red State voters do not want their tax dollars used to kill infants. There is no point of compromise between death and life! Blue State America intends to open the borders to all commers regardless of whether or not it will negatively impact taxpayers. There is no compromise between those who want to dispossess conservatives of their homeland and those wanting to repopulate America with socialist voting masses from the third world. The divide is irreconcilable under the current system of the supreme federal government. By now this should be evident to even the most ardent “one nation, under God, indivisible” timid conservative. There are none so blind as those who will not see! Take a look at a mere sample of the most recent neo-Marxist victories handed down by the Federal Supreme Court.

Three Strikes and You Should Be Out—of America’s neo-Marxist Union

The following three examples demonstrate the dilemma faced by America’s timid conservatives. As President Jefferson Davis noted, “The alternative to secession is

coercion.” For over 150 years “conservatives” have been the willing recipients of the Yankee Empire’s coercion.

Strike One: In a landmark 2012 decision the Supreme Court did judicial back-flips to hold Obamacare constitutional.⁴ Conservatives were shocked to find out that the Republican nominated “conservative” Chief Justice Roberts joined the four liberals in this decision. Strike one—demonstrates that we cannot rely on a “conservative” Federal Supreme Court to “drain the swamp.”

Strike Two: In a 2015 decision that overturned over 4,000 years of Judeo-Christian history in which marriage was defined as between one man and one woman the Federal Supreme Court declared unconstitutional the Defense of Marriage Act, thereby forcing states to recognize “Gay” marriage.⁵ Strike two—“conservative” Justice Kennedy joined the four liberal Justices in their successful effort to force “we the people” of once sovereign states to reject Christian morality while embracing the federally endorsed quasi-religion of secular humanism. The “non-religion” of secular humanism is now the U.S.A.’s officially protected and promoted quasi-religion.

Strike Three: In 2020 the Federal Supreme Court refused to hear Texas’ complaint regarding fraudulent acts used by partisan democrats to produce an apparent victory for Joe Biden.⁶ “We the people” of Red States and Red Counties that used legitimate (honest) voting and vote tabulation methods were denied equal protection under the law when other states and counties (Blue States and Blue Counties) used

illegal (voter fraud) methods to assure a partisan outcome favorable to their neo-Marxists candidate. Red State-Red County voters were denied equal treatment regarding the election of the president. If “we the people” have no “standing” to demand that the federal government’s leaders be selected in an honest election, then the only alternative is Red State-Red County secession.⁷ Strike three—proving once again that the Deep State has nothing to fear from “conservatives” and business-as-usual political campaigns.

The 2020 Presidential election proves that America is ruled by a neo-Marxist shadow government. The political class use it and are used by it to promote their extreme left-of-center agenda. As John C. Calhoun noted, “Power can only be countered by power.” If “we the people” of Red State-Red Counties do not move immediately to establish our counter-power—Provisional Governments⁸ in every Southern state—then the neo-Marxist have won. We act locally to undo the neo-Marxist power-center that the supreme federal government has become. We must work from the state level to demand a constitutional amendment acknowledging real States’ Rights inclusive of the rights of nullification and secession.⁹ If Blue State America refuses, then every Red State and Red County will secede and form a nation of our own. We must act boldly to hang our neo-Marxist enemies on the horns of a dilemma—either ratify our Sovereign State Amendment recognizing the rights of state nullification and secession or else, face a nation-wide secession movement.
