

## Shadow Governments in Dixie & Project 2020—Dixie's Brexit

Are you tired of seeing Confederate monuments defaced, destroyed and hearing those of us who understand the truth about the War for Southern Independence derided as "racists?" Are you tired of seeing black Southerners who honor their ancestors who wore the grey slandered and called "Uncle Toms" and physically threatened or attacked? Are your tired of seeing "conservative" politicians run and hide when we need them to stand up to the politically correct madness so rampant in our society today? If you are, then it is time for us to do something about it!

There are some folks in Southern Heritage organizations who believe that the best way to honor our Southern heritage is to abstain from anything political; avoid anything that might be controversial; and by all means never question whether the powers-that-be in today's America have a right to compel the people of Dixie's Bible-Belt to conform to the prevailing secular humanist anti-Christian political and social ideology. Such Southerners are misguided and wrong! Hiding in the closet will not prevent the secular leftist from completing their goal of exterminating everything that even hints at the traditional, conservative, God-fearing, South. The secular humanist enemies of the South view our Confederate monuments as "low hanging fruit" that they can destroy—an easy victory! These easy victories embolden their leftist mobs. It is their first effort to complete the extermination of the traditional South—a part of *their* empire that has for too long resisted their efforts to reconstruct us. How then do we effectually meet and ultimately defeat such a well-supplied and numerous enemy?

#### What Is A Shadow Government?

In the mid-1960s Donald and I were discussing the political condition of the South and how our politicians were not taking a leadership role in solving the issues of a second-class economy and the divisive racial problems of the day. The wise old Southern lawyer we were meeting with told us that we should never trust politicians because they are politicians! They look not to the future but to the next election. He told us that what the South needed was a shadow government in each Southern state—a shadow government so strong the it would be able to compel reluctant politicians to do what was best for the South or else! Donald and I looked at each other in bewilderment. It sounded like good advice but what would a shadow government look like and how would it be created? The advice was correct but the time (in midst of the Civil Rights movement) was incorrect. But today—today is the day, the time has come.

The means to establish and the role of shadow governments in each Southern state is described in *Dixie Rising—Rules for Rebels*. Essentially, the shadow government will act as a vehicle to arouse the sleeping Southern giant. The first and primary task is to establish a mechanism to inform our people about the evil Federal Empire that now rules over us. We must provide them with the truth about how the empire gained its unconstitutional position as our overlord. Southerners need to understand that their Confederate ancestors were fighting for Freedom! Once our people understand that they have the right to be the master in their own states, then we can move to the next step.



## DRAINING OKEFENOKEE SWAMP

Much has been said lately about "draining the swamp" of big government in Washington, a daunting task to be sure. Although a remarkable metaphor, the task at hand may be more complicated than just digging a ditch and draining off the "waters of corruption."

After the discovery of insects as a vector for the spread of deadly diseases, humans began the process of draining pools of stagnant water to reduce the numbers of disease laden insects. With swamps and other stagnant bodies of water removed, normal healthy living became the norm. Yet sometimes draining the swamp was not possible. If one had built his home on the Okefenokee or Atchafalaya swamps, America's two largest swamps, draining the swamp was an impossible task. ## Project 2020—A Southern Version of Brexit

Often, we are asked why we keep pushing the idea of a vote for freedom in the general election of 2020. We are politely reminded that we could never win such a vote. But when we provide our (short) answer we are often met with a look of compete amazement and bewilderment! You can almost hear their thoughts, "These men are crazy! Surely they can't be serious!"

The reaction is understandable. When most Southerners think about political activity they think about contesting elections—a contest in which there is a winner and a loser. Most of the time our candidate is the loser. When we tell folks that in conducting irregular political campaigns you do not have to win the vote to win the election—well that idea is totally counter to all that most people understand about politics. But remember all our prior efforts have not been successful—we need a new strategy if we expect to win. And irregular political warfare is not only a new strategy it is the only strategy that has been offered to create a mass movement for Freedom. We can win but not by doing the same things we have always done.

Suppose we manage to get our ballot initiative on only eight of the sixteen Southern states in the 2020 general election. Then we only gain a yes vote from a number of voters equal to 20% of the Republican votes in the 2016 election. Let Alabama represent the typical Southern state. Computing 20% of Alabama's 2016 Trump vote would be equal to 263,651 votes and if you multiply it by the 8 Southern states and you get a total of 2,109,208 votes for Freedom! This is not an insignificant number nor is it an improbable number if we are truly dedicated to the Cause of Freedom. No politician could afford to ignore a group that could rouse such a number of voters. We would become a real political force! It can happen! For more information about Project 2020, see:

### Docile submission to the Federal Empire does not equal vindication!

#### Letter from Missouri Confederate

We recently received a friendly letter from a fellow Southerner from Missouri. He is active in efforts to protect our liberties. He asked several questions regarding how we felt about Mark Levin's proposals for constitutional amendments; our position on the current efforts by politicians to convene a Constitutional Convention; and other interesting points. Below is our response.

We do not think Levin is on the correct track. He offers several amendments. You cannot pass an amendment every time the Feds do something that is unconstitutional—too work intensive and besides you may not be able to get 3/4s of the states to agree with you every time the Feds act-up. Our plan, as outlined in Dixie Rising-Rules for Rebels is to put a ballot initiative on the 2020 general election ballot giving the people of the South an opportunity to vote for a simple resolution demanding that the Feds place an amendment before the states acknowledging real states' rights—inclusive of the right of nullification and secession. With the right of nullification, the sovereign state will reclaim the right to protect its citizens from oppressive acts of the Federal Empire. (See: Kentucky & Virginia Resolves of 1798).

As for Constitutional Conventions—it is one of the many techniques we could use or threaten to use to compel the Feds to relent in their unconstitutional exercise of power over the South. But the important point is that we must first be organized to make sure **our** amendment is presented to the States or defeat any amendment that may come out that would be averse to our rights and liberty.


In Dixie Rising-Rules for Rebels we point out that it is foolish to try to out-spend the ruling elite (donor class) in traditional political efforts. We advocate using "irregular political warfare." This technique does not require winning elections in order to win our Freedom. Our first task is to awaken the sleeping giant—the vast numbers of Southerners who love the South but as of yet are not active supporters of the Cause. Awakening the sleeping giant and Project 2020 are the primary, but not the only, tasks of our shadow governments. Much greater detail is available in Dixie Rising-Rules for Rebels I urge you to get a copy and a copy of Punished With Poverty-the Suffering South. After reading these Kennedy books you will have a clear idea of what we mean when we advocate "Southern

Freedom." Hint: We are not a secession movement—we are a Freedom movement. America will <u>not</u> recover her constitutionally limited Republic of Republics using current political parties and traditional elections. The only question is whether we shall regain our constitutional Republic as the U.S.A. or the C.S.A.?

#### **Open Letter**

To: Louisiana Black Caucus

From: The Kennedy Twins of Louisiana

The Louisiana Black Caucus recently slandered thousands of Louisiana citizens when they attempted to connect our love and respect of our Southern heritage to the evil memory of "white supremacy." A famous Southerner once declared that he looked forward to the day when people are judged by the content of their character. To judge and viciously slander an entire group of people for political purposes is the worst form of bigotry. Prejudging a people without knowing their character or motives is nothing less than an act of prejudice that, of all people, black leaders, having suffered such insults, should want to avoid.

The harm done "yesterday" by chattel slavery and segregation will not be absolved by creating new divisions between our people today. Anger and hatred are useful tools for "ginning up the votes" and winning elections. But it has been the historical source of much of our current division. For instance, Radical Republicans used racial divide to garner control of the South during Reconstruction and in the process made many promises to newly freed slaves. While Radical Republicans gave away millions of acres of land out west-none was provided to the newly freed slaves. The reason was that Lincoln had already declared these western lands to be "white" reserved for people. announcement was met with enthusiastic applause from his Northern audience. As explained in *Punished With Poverty, the* Suffering South the technique of divide and rule has often been used to maintain

control of a people. It was and still is being used today.

What is the character of the vast majority of Louisianans who wish to protect the memory of our blood relatives who wore the gray in the War for Southern Independence? In 1989 the Sons of Confederate Veterans (SCV) passed a resolution denouncing the misuse or misappropriation of Confederate flags, symbols etc. by individuals or groups espousing "racial superiority." Violation of this standard is grounds for removal or denial of membership in the SCV. The Kennedy Twins have had personal experiences enforcing this standard here in Louisiana. Character matters. It is morally irresponsible to slander people who respect their ancestors stereotyping them as advocates of "white supremacy."

The "art of memory" allows us to memorialize individuals for their virtues. Things that we wish future generations to emulate. There are no perfect leaders—of the Confederacy, the Civil Rights movement or any other group. There are no leaders in which some fault, error, or indiscretion cannot be found. This most human factor should not be used to prevent us from honoring former Civil Rights, Confederate or other leaders—honoring them for their virtue.

The reasoning used to attack Confederate monuments could also be used to attack the monument to Governor Huey Long that stands on the Capitol grounds in Baton Rouge. Long is honored for his efforts to improve roads. provide free school books and forcing national corporations profiting from the exploitation of Louisiana oil/gas resources to return part of their profits to the people of this state. But he was also a racist who refused to support antilynching laws because "we only lynch an occasional n----r." Will the Black Caucus demand the removal of the Long monument? We hope not, because the monument points to the good done not the error (grievous as it was) of the man and his times.

All citizens of Louisiana should take pride in our heritage. Every time your child or grandchild hugs a Teddy Bear, you should think of a Black Confederate Veteran. Holt Collier. Collier was the hunting guide for Teddy Roosevelt who captured the small bear that Teddy refused to shoot—thus the "Teddy Bear" was born. As we point out in *The South* Was Right! there were thousands of Black Confederates. After the United States Supreme Court (not Confederate States Supreme Court) made the infamous "Jim Crow" laws the law of the land, it was white Confederate Veterans who defied both the law and local custom when they demanded and got the right to bury a Black Confederate veteran in the local "white only" cemetery. Levy Carnine was a member of the Pelican Rifles, Second Louisiana Volunteer Infantry and а local Confederate hero. To this day, he with remains side by side Confederate friends and his grave is cared for by the descendants of Confederate Veterans.



#### **HAWAII AND DIXIE**

The photo (top right column) of the only Royal Palace in the United States. It is the Palace of the Kingdom of Hawaii, a Kingdom that was invaded, conquered, and "reconstructed" by Yankees. On a recent trip to Hawaii, I took a tour of this impressive structure, Iolani Palace. As impressive as the structure is, the story that was related about how the Kingdom was overthrown and taken by the United States was for me, more remarkable. The Kingdom of Hawaii was founded in 1795 by King Kamehameha and lasted until 1893 when the last monarch; Queen Lili'uokalani was deposed. The Kingdom was taken over by Americans, children of Yankee missionaries and other Americans (all Yankees), who disenfranchised the native population. Without the support of the native population they forced the king to sign a new constitution, the Hawaiians referred to constitution as the "Bayonet Constitution," and slowly stripped the monarchy and native population of their right to rule themselves. All of this was being done while the United States Navy had warships in Pearl Harbor with the implied threat of the use of force if "American" interests were threatened. In 1893 the Queen was deposed and a "republic" was formed. This rogue republic had one guiding principle, union with the United States—something the native population did not desire. This rogue republic was established by a "white only" group of Americans and was fully backed by the United States military. These American usurpers were Yankees; they were all from Northern States or children of parents from Northern States. The Queen was subsequently arrested and held in Iolani Palace on the charge of treason. All of this should sound familiar to Southerners! As we were leaving the Palace the tour guide mentioned that before the Kingdom was overthrown, guests of the Royal family would sit on the second story balcony and view the ocean but we could not see the water today because the view is now blocked by a big Federal Building. The Federal Empire has been blocking more than just a beautiful view for too many Americans, it's time to reclaim our lost estate of liberty whether in Hawaii or Dixie!
